# SELLING SETTLEMENTS

## The Occupied Golan's Settlement Industries

Israel continues to use the expansion of industry and settlements to legitimize and cement control of the territories it occupies. The world is slowly starting to notice this and react. Over the past decade, there has been growing support for boycotting products from Israeli settlements in the occupied Palestinian territories. However, few people have paid attention to the similar issue of illegal settlement production in the occupied Syrian Golan ('the Golan').

Israel's occupation of the Golan has had long-lasting and severe effects on the native Syrian population. The lack of attention paid to the occupation has paved the way for Israel not only to establish residential settlements, but also to create companies and industries in settlements that are constantly growing and are major contributors to the Israeli economy. Many of these companies compete at an international level and are selling and exporting their products worldwide.

Al-Marsad counted 167 businesses that are operating out of Israeli settlements in the Golan. This report is published with an appendix that includes a list of these companies with brief descriptions of their services. This is the first comprehensive list of its kind that identifies Israeli settlement

businesses operating in the Golan.

The following report will discuss and analyse: the background of how the Golan got to where it is today; the illegality of Israel's settlements in the Golan; the motivation behind the continued expansion of settlement businesses despite their illegality; how labelling and international regulations impact settlement businesses; how settlement businesses destroy local Syrian industries; and, examples of current settlement businesses in the Golan. Ultimately, this report shows how settlement businesses destroy native industries and contribute to the 'Israelization' of the Golan.

### ***I. Background***

Israel has occupied the Golan since the 1967 Arab-Israeli War. The war and subsequent occupation was devastating for the native Syrian population. Approximately 130,000 people - amounting to 95 percent of the total population of the Golan - fled their homes and/or were forcibly transferred from the Golan by the Israeli army. Of the Golan's 345 Syrian villages and farms, 340 were destroyed by the Israeli army. The ruins of these villages were then used to build Israeli settlements and fortifications. In 1981, the Israeli Knesset voted, with a majority of 63 to 21<sup>1</sup>, to annex the

Golan. This illegal act was widely condemned by the international community.<sup>2</sup>

Today, there are approximately 27,000 Israeli settlers living in 34 illegal settlements in the Golan.<sup>3</sup> Together with the Israeli military and authorities, they control 95 percent of the Golan's land.<sup>4</sup> Senior Israeli government ministers, such as Yisrael Katz<sup>5</sup> and Naftali Bennet<sup>6</sup>, have repeatedly called for 100,000 more settlers to move to the Golan. New and existing settlers obtain major benefits to live in the Golan, including tax exemptions and reduced rent costs.<sup>7</sup> The remaining native Syrian population of the Golan, approximately 26,800 people, live in five villages located in the north of the region and control approximately five percent of the Golan's land.<sup>8</sup>

## ***II. The Illegality of the Occupation***

The international community continues to reject and denounce Israel's occupation of the Golan and expansion of settlements as illegal. The Fourth Geneva Convention condemns the transfer of civilians to occupied territories to establish settlements.<sup>9</sup> Furthermore, the Hague Regulations, at Article 55, state, 'The occupying State shall be regarded only as administrator and usufructuary . . . It must safeguard the capital of these (occupied) properties and administer them in accordance with the rules of usufruct'.<sup>10</sup> This essentially means that an occupying state has an obligation not to make permanent changes in occupied territory and is prohibited from exploiting the economic resources of the occupied territory for its own domestic

benefit.<sup>11</sup> Accordingly, 'it is required to keep the occupied territory separate, politically as well as economically'.<sup>12</sup> Additionally, the United Nations Security Council, whose resolutions are binding, has repeatedly declared Israeli settlements in occupied territories illegal.<sup>13</sup>

Israel continues to ignore all international law forbidding settlement activities and expansion. Regardless of Israel's apathy, the settlements in the Golan and their companies and industries should not be exploiting the resources in the region and selling their products on the Israeli and/or international markets. Such acts unambiguously violate international law.



In recent years, Israel doubled down on its illegal settlement and business expansion in the Golan. In addition to continuing to call for increased migration into the Golan<sup>14</sup>, Israel has used the Syrian Civil War to argue that there is no country for the Golan to be returned to.<sup>15</sup> Since the onset of the Syrian Civil War in 2011, Israel has increased Golan settlement populations by almost one-third – from 19,635 in 2010 to 26,261 in 2017.<sup>16</sup>

Furthermore, supporters of Israel's occupation of the Golan have recently seemed more inclined to cite biblical references to the region as part of "the Land of Israel" to justify their 'legal' right to control the area indefinitely.<sup>17</sup> In 2016, Israeli Prime Minister Benjamin Netanyahu stated that 'the Golan Heights will remain under Israel's sovereignty permanently' during the first Israeli cabinet meeting in the Golan.<sup>18</sup> Despite these efforts, Israel still stands alone in its claim over the Golan and its actions in the region remain blatant violations of international law.

### ***III. Motivation Behind the Economic Occupation***

The Golan is known for its fertile soil, potential for oil production, tourist industry and water resources. The Golan is well suited to grow various fruit and other crops. Before Israel's occupation, the native Syrian population raised livestock and grew grains, fruits and vegetables.<sup>19</sup> Today, Syrians only grow apples and cherries in the Golan while Israeli settlers cultivate everything that the Syrians used to produce and more.<sup>20</sup> Perhaps the largest hijacked industry in the Golan has been grape production. The Golan has gained a strong reputation around the globe for producing wine. Nearly half of Israel's wine is produced in the Upper Galilee and Golan Heights regions.<sup>21</sup> Additionally, grapes grown in the Golan are used to supply all major wine producers in Israel.<sup>22</sup>

Oil exploration has taken place throughout the Golan since the early 1990s but has ramped

up in recent years as Israel tries to expand its control over the region.<sup>23</sup> To date, oil companies have yet to find a substantial source of oil in the Golan; however, small oil reservoirs have been located, leading to encouraged and enhanced drilling.<sup>24</sup> In fact, Afek Oil & Gas – a subsidiary of the United States ('U.S.')->based Genie Energy, which has former U.S. Vice President Dick Cheney and billionaire Rupert Murdoch on its advisory board – has claimed that the Golan may contain 'billions of barrels' of oil.<sup>25</sup>

The tourist industry in the Golan is expansive and growing. The Golan is visited by over two million tourists each year.<sup>26</sup> Most of these tourists are directed to Israeli settlements, sites and activities. For instance, a recent search found that at least 130 properties – almost all the listings – on Air BnB (a popular alternative travel accommodation website) in the Golan were in Israeli settlements. This as the Israeli Ministry of Tourism recently invested NIS 18.5 million (about USD \$5 million) in cooperating more with major online travel companies.<sup>27</sup>

Water and the access to water are also significant motivations for the Israeli government to solidify its position in the Golan. The World Resources Institute lists Syria and Israel (as well as Jordan and Lebanon) as some of the most water-stressed countries in the world.<sup>28</sup> This exemplifies the dire need of access to water in the region. The Golan is very water rich and therefore extremely important to Israel as a source of fresh water. Over one-third of Israel's water consumption annually is sourced from Golan.<sup>29</sup>

The Israeli industries in the Golan contribute significantly to Israel's economy. For instance, in 2015, Israel made USD \$371 million in profits from agricultural products from the Golan alone.<sup>30</sup> Furthermore, many Golan-based companies are expanding operations overseas. Aside from manipulating the resources of the local population to profit for itself, the Israeli government's tactics of maximizing the use of industries and businesses in the Golan helps solidify its territorial presence. The more Israel is able to establish businesses and profits from the region, the more it is able to intimately link the region to itself and claim that it has a sovereign right to control it.



#### **IV. International Regulation: Settlement Industries and the Issue of Labelling**

Only a month after the Israeli occupation began in 1967, the first settlement, Merom Golan, was established. Since then, 167

companies and businesses have been created in 29 settlements in the Golan.<sup>31</sup> The majority of settlement companies, 89, are based in Katzrin. Katzrin is the biggest Israeli settlement in the Golan.<sup>32</sup> Additionally, there are numerous companies not located in the Golan that market Golan settlement products or use raw materials from the settlements. These companies range from small family businesses to large factories that compete on the international market and export globally. These businesses include a number of wineries, technology innovation groups, medical supply manufacturers and beauty products manufacturers.<sup>33</sup>

The true origin of many of the products manufactured in the Golan is often purposefully obscured. Since the Golan is an occupied region, its products should be advertised and labelled accordingly. Numerous countries declare that labelling products from the Golan as 'products from Israel' is incorrect. For instance, the European Commission stated in the *Interpretive Notice on Indication of Origin of Goods from the Territories Occupied by Israel since June 1967* that 'products from the Golan Heights' cannot contain 'made in Israel' labels.<sup>34</sup> Instead, the notice requires an Israeli product from the occupied territory be referred to and labelled as a 'product from the Golan Heights (Israeli settlement)' or an equivalent.<sup>35</sup> The U.S. promotes similar guidelines, making the mislabelling of a product made in an Israeli occupied territory as 'made in Israel' improper.<sup>36</sup>

The enforcement of such labelling guidelines,

which have been around for some time, by regulators has been inconsistent. Some companies avoid following the labelling requirements completely, while others avoid the regulations by shipping raw material to Israel to be processed and packaged there. Despite these discouraging practices, activists and advocates for proper labelling for settlement goods have noticed that foreign companies are aware of and, at times, sensitive to whether or not their products are sourced from settlements.<sup>37</sup> As multinational companies become more socially aware and refuse to endorse settlement products or require proper labelling for such products, the impact of labelling regulations will become more significant.

More adequate enforcement and more states enacting labelling regulations will certainly serve as a check on Israel's increased economic activity in occupied territories. Proper labelling combined with socially conscious consumers will help stem Israel's continued violation of international law through its operation of settlement businesses.

**V. Impact of Settlement Businesses on the Syrian population**

Settlement industries have had a devastating impact on the local communities in the Golan. In the aftermath of the 1967 occupation of the Golan, the Israeli military expropriated a massive amount of land and is estimated to have expelled over one hundred thousand individuals<sup>38</sup> whose livelihoods were based on the land.<sup>39</sup> Syrians that remained in the Golan

lost up to half of the agricultural property they once owned.<sup>40</sup> Some of the land seized by Israel remains unused to this day.<sup>41</sup>



After the occupation began, Israel quickly started instituting policies and practices to remove competition from native Syrian farmers and redistribute resources to advantage settlers and their business.<sup>42</sup> For instance, the way land was expropriated destroyed the native Syrians' field crop and dairy production, forcing Syrians to depend on Israeli products, including settlement products, to fill this new void.<sup>43</sup> Similarly, Israeli authorities began to heavily regulate Syrians' access to water resources for agricultural purposes, limiting access for the native Syrians while providing unlimited amounts of water to settlers at extremely low costs.<sup>44</sup> Even basic infrastructure remains limited for native Syrians. Although Syrians pay taxes to Israeli authorities, basic utilities, including effective sewage facilities, are not provided to the native community.<sup>45</sup>

Syrians are also negatively impacted by the Israeli government's constant direct support for Israeli settlers. The Israeli government encourages settlers and settlement production

through special tax incentives, relaxed labour and environmental regulations, low rent and even direct government financing.<sup>46</sup> This support is used to meld occupied land into Israel.<sup>47</sup> This perpetuates the occupation and further undermines the economic and social strength of the native Syrian community.

Additionally, Syrians have been forced to work for settlers and settlement companies to earn a living. For example, the Neve Ativ settlement in the Golan was built just down the road from the Syrian village of Majdal Shams with the involvement of Syrian construction contractors.<sup>48</sup> It is of note that Neve Ativ is built directly on top of the ruins of a Syrian village that was destroyed by Israeli forces.<sup>49</sup>

When the Israeli government chooses to support the Syrian population, they do so in disorganized ways – sometimes even hurting the industries they claim to be helping. For example, one recent investment to renovate a major road in Majdal Shams was pitched as Israel supporting the Syrian population. However, the road – which was haphazardly built to more efficiently connect Israel to the only ski resort, located in occupied territory – negatively impacted the Majdal Shams community. The renovation heavily restricted access to the businesses that sit along the road by virtually eliminating street parking.<sup>50</sup> These businesses, prior to the road being built, were frequented by tourist traffic from the ski resort.<sup>51</sup>

Overall, Israel has unwaveringly supported settlers and their businesses to the extreme

detriment of the Syrian population. Israeli policies and practices continue to demoralize and destroy the Syrian population of the Golan.

## VI. *Illegal settlement industries*

To understand the presence and diversity of settlement businesses, a few examples of settlement companies are described here. These examples are meant to supplement the extensive list of settlement companies attached in the appendix to this report.



**Olea Essence**<sup>52</sup> is situated in Katzrin. The company was established in 1997 and advertises itself as a business that is unique and exclusive not only in its product but also in its waste management, disposing of its used products in environmentally friendly ways. The main commodities that the Olea Essence offers are Carpernaum Extra Olive Oil and beauty products. The company then uses leftover olive residue to produce eco-friendly cleaning products. These products are certified as 'Green' by the non-profit organisation Green Seal. The U.S.-based Whole Foods is one of the biggest buyers of Eco Olea Green products.<sup>53</sup>

Olea Essence has a visitor centre and shop at its headquarters in Katzrin, and stores in Tel Aviv, Jerusalem and Japan. Aside from its storefront presence, Olea Essence's products can be purchased online and are shipped worldwide. The company is also extremely active on social media where it advertises its products and claims they are made in Israel – not an Israeli settlement in the Golan.

**Bental Industries Ltd.** is located in the first Israeli settlement in the Golan, Merom Golan. The company is one of Israel's leading suppliers in military products and motion and power systems. The business also supplies industrial and military companies worldwide. In addition to the Israeli army, its clients include Boeing, Raytheon, Korean Air Industries, RIX Industries and more.<sup>54</sup> The company was acquired by another Israeli company, TAT Technologies, in 2008.<sup>55</sup>



**Golan Heights Winery** is one of several wineries across the Golan. The wine industry in the Golan is hugely important to Israeli settlement industries and many Israeli wineries in the Golan compete in global markets. Golan Heights Winery alone produces over one million bottles of wine a year.<sup>56</sup> Smaller

wineries in the region produce between 8,000-20,000 bottles a year, with Europe and the U.S. being major export destinations.<sup>57</sup> Not only do these businesses produce wine, they also advertise visits and guided tours at their facilities, which they claim are in Israel.

Golan Heights Winery, like other settlement corporations, openly discusses its strict adherence to 'corporate responsibility'.<sup>58</sup> The winery boasts that it is an 'integral part of the human fabric and creative energy of the Golan Heights'.<sup>59</sup> However, it does not acknowledge or recognize that it operates on occupied territory or that native Syrians are suffering because of the Israeli occupation. To the contrary, the winery markets itself as an Israeli business operating in Israel.<sup>60</sup> It is abhorrent that Golan Heights Winery sees itself as part of the 'fabric' of a land whose illegal occupation it supports to the detriment of the land's local population.

**Enlight Renewable Energy Ltd.** is an Israeli company that is based in Israel<sup>61</sup>; however, it is advancing one of an estimated 15 projects vying to create wind turbine farms in the Golan.<sup>62</sup> Enlight plans to construct 30 wind turbines that will create 96 megawatts of electricity, the equivalent of supplying 40,000 households with electricity.<sup>63</sup> The wind farm's electricity will supply Israel's main power grid and will be sold throughout Israel.<sup>64</sup> Enlight's project is just one example of a growing trend taking place in the Golan – companies entering the region to search for and exploit its natural resources. In addition to wind energy, companies like Afek Oil & Gas, discussed

above, are scouring the area in search of oil.<sup>65</sup>

## **VII. Conclusion**

Settlement businesses in the Golan are strong and growing stronger at the expense of the native Syrian population through the exploitation of Syrian land without regard for international law. Discriminatory policies and practices have adversely impacted Syrians' daily lives and stifled their ability to develop a prosperous and vibrant economy. Israel's exploitation of the Golan's natural resources also violates Syrians' rights to freely dispose of their natural wealth and resources.

The international community has failed to prevent Israel's economic exploitation of the Golan. While it occasionally condemns Israeli violations of international law in occupied territories, the absence of definitive action by

the international community leaves the native Syrian population vulnerable to continued economic predation by Israel. However, as civil society actors continue to draw attention to Israel's economic exploitation of occupied territories, there may be some hope for change in the future.

With no foreseeable end to the occupation in sight, we demand that the international community ensure that Israeli authorities end discriminatory policies against the Syrian population, halt settlement expansion and cease the exploitation of the Golan's natural resources. In the short term, proper origin labelling must be enforced so that consumers purchasing items from occupied territories are aware of the true origin of their purchases. Ultimately, Israel's illegal settlement businesses must no longer be able to operate with impunity.

Below is a list of companies operating in illegal Israeli settlements in the occupied Syrian Golan. The list contains: the company name; the settlement in which it is based; a summary of activities; Israeli Company Registrar number (if relevant/available); and company website or third party website identifying the company. Dates of establishment are omitted, yet every company included in the list was established after Israel's occupation of the Golan began. Most of these companies have been created in the last 20 years, as the Israeli government continues to push for an increased Israeli presence in the occupied territory.

The following list is based on comprehensive, open-source research. The companies were initially identified using an Israeli website ([www.corporation.co.il](http://www.corporation.co.il)) that compiles information on companies registered with Israeli authorities. This information was supplemented by additional research to confirm the company's existence, practices, and place of business. The data collected here is updated to the date of this report's publishing.
