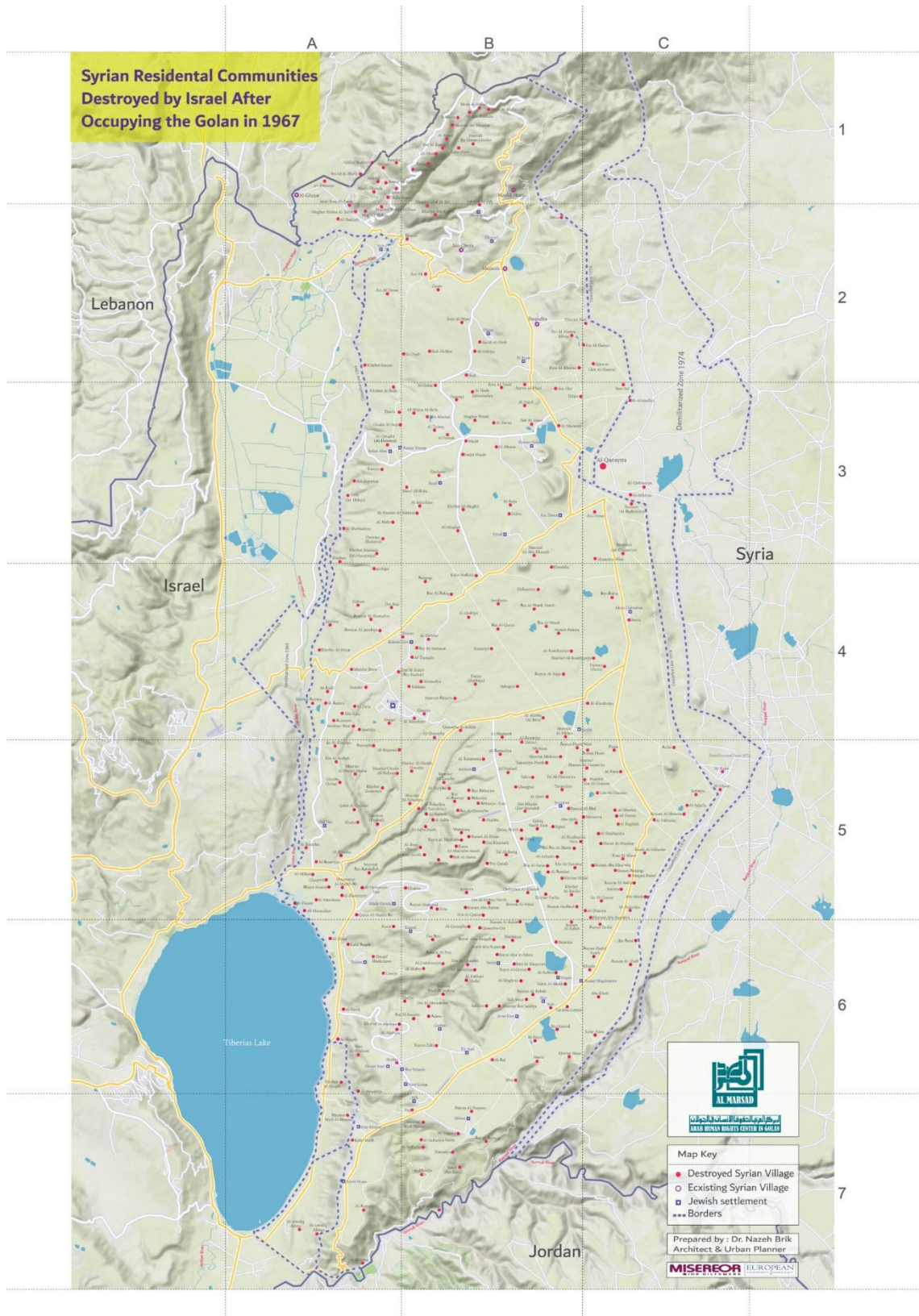

## **1. INTRODUCTION**

Al-Marsad – Arab Human Rights Centre in Golan Heights ('Al-Marsad') pursued its core activities during 2023 of monitoring, documenting, researching, and raising awareness of the human rights situation in the occupied Syrian Golan. This report explores the organization's research activities, awareness-raising/advocacy, Cultural festival "**Golan Cultural Days - 3**", and legal aid provided to the Syrian community in the occupied Golan during the reporting period. The activities include, among others, correspondence with Israeli authorities; workshops for the local community; legal aid (consultations and litigation); Advocacy; field visits for local and international delegations; The organization of a Third cultural festival; meetings and correspondence with journalists, government officials, and politicians.

Al-Marsad continued during 2023 to deepen cooperation with the indigenous Syrian community, overcoming challenges that influenced it and strengthening its international and local credibility and reputation as the only human rights NGO in the occupied Syrian Golan. Besides, the organization is still intensively engaged in the legal activity of supporting the Syrian community's peaceful struggle against the wind farm project cooperation with dozens of local agriculture cooperatives and hundreds of Syrian farmers. Moreover, Al-Marsad strengthened its collaboration with different grassroots initiatives and groups in the Golan, such as the Fateh Al-Mudarris Centre for Culture and Arts, the Golan for Developing Arab Villages and others.

The Israeli occupation authority is taking advantage of the ongoing conflict in Syria proper and the de facto division of the country into several intertities to strengthen its control over the Golan. Hence, they continue to create new facts on the ground that are difficult to hang in the future, mainly through the expansion of the Illegal settlement and resettlement of Jewish settlers. This will increase uncertainty about the future of the remaining Syrian community in the occupied Golan and more than half a million displaced persons.

The Syrian community suffers from Israel's discriminatory policies, which violate their fundamental rights, including the right to adequate housing; The seizure of land and severe restrictions on the use of land for urban planning and expansion; the presence of dozens of minefields between agricultural fields and adjacent to Arab villages; Frequent power cuts in Syrian towns, especially in the freezing winter, due to defects and shortcomings in the electricity networks inside the villages. Moreover, the Israeli authorities refuse to register newborns whose families stay abroad for work or study because they were born to families with Israeli residency. Still, they choose their "life centre" outside Israel.

## **2. CHANGES IN THE SITUATIONAL CONTEXT AND THE ORGANIZATION'S ACTIVITIES**

As usual, the Israeli authorities took advantage of the military conflict in Syria to impose new facts to prolong the occupation by setting new facts on the ground while pursuing discriminatory policies against the remaining indigenous Syrian community on the occupied Golan. Israel also utilized the "Trump Declaration," which recognized Israel's 'sovereignty' over the Golan in 2019 to escalate settlement expansion, exploitation of natural resources, and Israelization policies designed to undermine the Syrian identity of the remaining indigenous Syrian community.

Israel continues developing wind farm projects (24 wind turbines, up to 220 meters in height each) owned by Energex Renewable Energies Ltd. Despite massive public opposition, the company began implementing the project after obtaining building permits. As mentioned, Al-Marsad has been following the developments on the ground, affording legal aid and

consultations to thousands of affected farmers and eight agriculture cooperatives. We also keep cooperating with our partners, the Association of Civil Rights in Israel ('ACRI') and Planners for Planning Rights ('BIMKOM'), to contest the project from a legal perspective.

Contesting the project angered the company and a few local agents in the Golan. As a result, they launched a systematic slander campaign at the beginning of 2019 targeting the organization, its staff, and their families, which has lasted until now. Al-Marsad administration has recently decided to file a defamation case against these people before the Nazareth District Court to silence them.

On 20 June 2023, Israel sent hundreds of Special Police officers to the Golan to protect the wind turbine project being resisted by Syrian residents. The state forces blocked community access points and dispersed peaceful demonstrators who had gathered for a vigil on their lands. Police deployed tear gas, water cannons, rubber bullets, and live rounds, injuring 27, including five in critical condition. This is a violent response to the legitimate longstanding protest of the people of the Golan against energy projects seeking to profit during the occupation.

As a result of these bloody confrontations, resulting from the use of excessive force by the Police and random shooting at the upper extremities of the bodies of peaceful protesters, the company stopped the project implementation, and police forces withdrew from the agriculture fields. The Israeli Prime Minister Binyamin established a committee led by his primary consultant. The committee comprises a dozen members representing native Syrians in the Golan, including Al-Marsad's lawyer, Druze's leadership in Israel, an Energex representative, and representatives of several Israeli ministries and security agencies. The committee has been negotiated for a few weeks without reaching any significant understanding. While the Energex company insists on implementing the project, the representatives of the native Syrian community categorically oppose the project.

### **3. IMPORTANT CHANGES WITHIN AL-MARSAD**

The organization continues to increase its advocacy work among the local community and internationally regarding the human rights situation in the occupied Syrian Golan. The "Golan Cultural Days—3" festival was held for the third time from 29 July to 6 August 2023 in cooperation with several local initiatives, including the Fateh Al-Mudarris Centre for Culture and Arts, women and youth initiatives, and the Golan for Developing Arab Villages.

### **4. IMPLEMENTATION OF ACTIVITIES**

The organization's team conducted in 2023 the planned activities of legal research, UN submissions, a cultural festival, and advocacy. It cooperated with local and international NGOs and coalitions, mainly with the ESCR-Net, the International Federation for Human Rights (FIDH), the Euro-Med Network for Human Rights, and various local human NGOs and activists.

## 6. Legal aid and representation:

- 331 in-house legal consultations on various issues: Labor rights, Wind turbine projects, planning and housing rights, and policies of Israeli authorities (local councils, ministries, government companies, social security).
- Follow-up case of family unification in cooperation with ACRI.
- Providing legal support for the agriculture cooperatives and farmers to support their legal struggle against the wind turbine project implemented by “Energex for Renewable Energy.” In this context, Al-Marsad achieved several activities, including:
  - Conducting 8 Meetings at the Al-Marsad office with the heads of the agriculture cooperatives to follow up on the wind turbine project implementation.
  - Continuo provided extensive legal support to 6 agriculture cooperatives in front of their private law office, “Tadmor Levy,” to facilitate their case of challenging private contracts with “Energex for Renewable Energy”.
- A letter to the Israel Police under the Freedom of Information Law asks whether Energy paid the police officers who backed up Energex on 09/12/2021.
- Write a letter to the Local Planning Committee to reveal information regarding acceptable amounts paid due to building violations in the five Syrian villages in the Golan.
- Four workshops with local activists while preparing for the festival (Jawlan Cultural Days).
- Three workshops by Zoom with the Association for Civil Rights in Israel (ACRI).
- Two cases were filed to the District Labor Court in Nazareth (case No. 11818-07-21 and case No. 18959-04-22)
- Three cases are being evaluated, and potential compensation amounts are calculated.

- Coordinate with ACRI to file a petition to challenge the poor electricity network in the Syrian villages and to end the daily electricity cuts, mainly during the winter. ACRI Team (4 Lawyers) will visit the Golan to conduct a field tour to learn about the problems of the electricity network on the 3<sup>rd</sup> of August.
- Follow up with Tadmor Levy Law Firm on the civil case to challenge the legal aspects of the wind farm project. The lawyer works closely with the law firm, coordinates meetings, and explains to the agriculture cooperatives and their members the legal dimensions and development of the case. The lawyer participates in the hearings, conducts research, gathers core information for the case, and prepares and approves 94 sworn statements of local farmers affected by the wind farm.
- Signing dozens of powers of attorney and approval of dozens of affidavits regarding the turbines project.
- Submitting an objection to a general building plan of the village Majdal Shams.
- Representing Al-Marsad in meetings with a senior official from the Israeli Prime Minister's Office and representatives of government ministries to discuss different aspects of the wind turbine project (3 sessions). The role of the Al-Marsad lawyer is to inform the government representatives of the project's legal aspects and existing violations.
- Al-Marsad lawyer accompanied several farmers to the Tiberias police station to file a complaint accusing Energex company of fraud regarding the wind turbine project.
- Al-Marsad seeks to afford constant legal support for agriculture cooperatives and farmers in their legal struggle against the wind turbine project implemented by "Energex for Renewable Energy." In this context, Al-Marsad achieved several activities, including:
  - Weekly meetings with the heads of the agriculture cooperatives to follow up on the wind turbine project developments.
- Prepare and approve dozens of sworn statements from local farmers regarding the wind turbine case.

12. Organizing a joint workshop in cooperation with Fateh Al-Mudarris Centre for Culture and Arts in the field of theatre, acting and storytelling, dedicated to the younger generation, as tools for self-awareness and dealing with the feelings and contradictions surrounding young people's lives.
13. Communicating with the Cultural Department of the Spanish consulate in Jerusalem, discussing the possibilities of cooperation and round-trip participation in the program

"Internationalization of Spanish culture," which will extend over 2024 and include artistic exchanges, partnerships, and mutual artistic residencies.

14. Meetings and Follow-up with the documentary filmmaker, Salim Abu Jabal, to provide him with the necessary data to complete the script for his documentary film about the wind turbine project in the Golan.
15. Coordinated and planned workshops related to screenwriting, filming, and editing in cooperation with and through the project of filmmaker Salim Abu Jabal and in coordination with the Fatih Al-Modarres Center for Arts and Culture.
16. Preparations for the launch of the "Cinema Club" project during the spring of 2024. joint activity in cooperation with Fateh Al-Mudarris Centre for Culture and Arts

## **10. STAFF MEMBERS' ACTIVITIES**

Staff engaged in the following activities throughout 2021:

### **A. Salam Said Ahmad, Executive Secretary/Accountant**

- Conducted daily administrative and financial tasks;
- Prepared salaries and transferred them to employee's bank accounts;
- Paid taxes and office bills, monitored Al-Marsad's bank account, and followed up on financial issues with the accounting office and the program auditor;
- Prepared financial reports in coordination with the program auditor; and,
- Updated the organization's website, entering data regularly;

### **B. Wael Tarabieh – Manager, Economic, Social, and Cultural Rights Program**

#### **F. Interns**

The International Interns Program has not regained momentum since the COVID-19 Pandemic coronavirus outbreak in early 2020. Therefore, a few interns were engaged remotely in helping the organization draft legal research and submissions during 2022.

Throughout 2022, dozens of local interns contributed to Al-Marsad’s work. The interns were intensively engaged mainly in supporting the cultural festival “Golan Cultural Days—2.”

### **11. CONCLUSIONS AND HIGHLIGHTS**

Al-Marsad pursued its core human rights activities of conducting legal research, providing legal services (representations and consultations), performing local and international advocacy, and conducting the festival “Jawlan Cultural Days 3,” which will take place from July 30- August 6, 2023. Al-Marsad maintained productive cooperation and partnership with human rights organizations in Palestine/Israel, basically ACRI, BIMKOM, and Adalah.

The organization’s team continued investigating and researching the human rights situation in the Golan, reporting to the relevant Israeli authorities, and challenging human rights violations and discriminatory policies before Israeli authorities and courts.

International and Local coalitions and partnerships enabled the organization to conduct advocacy activities to raise awareness about the human rights situation in the occupied Golan. We keep witnessing monumental achievements in local advocacy among the indigenous Syrian population of the Golan.

- Al-Marsad has also preserved its advocacy before the U.N and several international NGOs, mainly the International Network for Economic, Social and Cultural Rights (ESCR-NET), Cornell University Law Clinic, International Labor Organization (ILO), the UN Independent International Commission of Inquiry on the Occupied Palestinian Territory, Including East Jerusalem and Israel, Business & Human Rights Resource Center, International Federation for Human rights (FIDH), Euro-Med Network for Human Rights, Cairo Institute for Human Rights Studies (CIHRS).

Al-Marsad’s workload still increased to meet the local Syrian community's growing demands and maintain cooperation with regional and international partners. The organization puts enormous efforts into mobilizing new funding sources to meet these challenges.
